- **13.** Ensure that food provision is carried out within the guidelines of the food safety act 1990, and is balanced and healthy in accordance with dietary requirements.
- **14.** Ensure that a wide range of creative and enjoyable activities are offered.

- **16.** To promote the aims and objectives of the Club/Scheme/School, and use as a guide for daily activities.
- 17. Be aware of Staff Policies and Practices.
- **18.** To ensure the provision of good standards of physical and emotional care.
- **19.** To ensure good standards of hygiene and cleanliness are maintained at all times.
- **20.** To be responsible for the Health and Safety standards appropriate for the needs of the children.
- **21.** To ensure that the preparation and maintenance of materials and equipment are undertaken.
- 22. To record accidents in the accident book.
- 23. To ensure someone known to the club collects the child.
- **24.** To ensure the provision of a high quality environment to meet the needs of individual children from differing cultures and religious backgrounds, and stages of development.
- **25.** To ensure confidentially of information received.
- 26. To be aware of the high profile of the club and to uphold its standards at all times.
- **27.** To be involved in out of working hours activities e.g. training, staff meetings.
- **28.** To undertake such other duties and responsibilities of an equivalent nature as may be determined from time to time by the club/scheme.
- **29.** To comply with the Council's Health and Safety Policy and associated safe working procedures and guidelines.
- **30.** To comply with the Council's Comprehensive Equality Policy and to ensure that it is implemented within the service area of the post.
